WHAT WE COLLECT

These Terms of Use (the "Terms of Use") are issued by Fort Wayne Intermediaries, Inc. ("FWI," "we," "our").

ReliableLivingPlan.com is an informational website of FWI. FWI is a licensed business entity insurance producer (Indiana Producer License no. 3131546; National Producer License no. 4475875). FWI is appointed by Americo Financial Life And Annuity Insurance Company to distribute the Reliable Living Plan on Policy Form #ICC 15-600. We only collect your personal information when you submit it to us to learn more about our product. This is what we collect:

- Contact information that you submit to us.
- Information that you enter into any Message fields, chat boxes, or otherwise provide our agents.

WHAT WE DO WITH IT

We only use personal information for legitimate business purposes, such as

Due to the global nature of our business, for the purposes set out above we may transfer information to parties located in other countries.
